Purpose and Explanation of the Amendment

The **Lead Historic District (NRIS#74001892)** was listed in the National Register in 1974. Typical of early nominations, information provided in the National Register form is minimal. The original nomination mentions only ten of the approximately 800 primary structures within the district boundary. Additionally, the verbal boundary description is vague and inconsistent with other sections of the nomination. Also, no map was submitted with the original nomination. Lastly, the significance section contains only eight paragraphs and does not offer a complete explanation of the district's importance or justification for a period of significance.

This amendment will assign contributing/non-contributing statuses, define the boundary, create a map, define a period of significance, and provide additional documentation that speaks to the district's historic and architectural significance.

The boundary description in the 1974 nomination is vague, confusing, and unclear. This is not unexpected when one considers Lead's mountainous terrain, winding streets, and industrial mining landscape. These factors, combined with the lack of technology available in 1974 to clearly specify exact boundary points, create interpretation difficulties.

The amendment is classified as **boundary decrease/increase**. In the original nomination, *1204 Washington Street* is one of the ten significant properties called out in the description section. However, under no interpretation of the verbal boundary description does this property fall within the district's boundary. This house no longer has integrity and the majority of the houses in the four-block vicinity of the house would not be contributing to the district. Therefore, *1204 Washington Street* and the houses between it and the 1974 boundary are not included as part of the district. The 1974 boundary clearly does not include *1204 Washington Street*, but since it was mentioned in the 1974 description section, its exclusion is being treated as a boundary decrease in this amendment. Additionally, the boundary is increasing in one area in order to fully encapsulate a contributing resource partially located within the 1974 boundary. The 1974 boundary appears to cut off part of the Open Cut site, which is being considered a contributing resource to the district. The boundary will expand north in order to fully include this site. Besides the two situations mentioned above, the 1974 boundary will remain intact, as interpreted by SHPO. The intent of the new boundary is to include all 1974 nomination resources (as within the interpreted boundary) and not include resources excluded in 1974.

Since the boundary in the 1974 nomination is so confusing, it is impossible to describe in more detail areas and resources being removed or added to the 2019 updated boundary. The reasons for the increases/decreases are detailed above in as much detail as possible given the interpretability of the 1974 nomination. Additionally, a map showing the increases/decreases is not included in the 2019 amendment, which only contains a map with the new boundary with updated contributing/noncontributing classifications. Once again, the vagueness of the 1974 nomination does not make it possible to depict on a map increases or decreases to the district because it is impossible to definitively determine what areas and resources were supposed to be within the 1974 boundary.

Given the terrain of the district, building layouts in relation to that terrain, and changes to the built environment and landscape since 1974, it not possible to fully interpret what the 1974 nomination intended. Occasionally, placement of the boundary line may seem arbitrary given the correlation in appearance or function of resources on either side of the line. This is particularly true in areas where the boundary was clearly defined in the nomination, such as be denoting as running down the middle of the street. This amendment is intended only to clarify the 1974 boundary and make contributing and noncontributing classifications. Areas outside of the interpreted 1974 boundary in this (2019) amendment may be amended into the district at a future date if funding and public support dictate that endeavor.

Summary Paragraph

Lead is located in the northern Black Hills, a mountainous area of western South Dakota, and is 5,218 feet above sea level. The terrain is steep mountains and narrow valleys. The Lead Historic District encompasses southern, central, and southwestern sections of the city. The commercial area sits in a valley running east to west. Above this area, houses are scaled up the mountains. At the top the mountains on the south side of town are mine-related buildings including large shaft houses. Ponderosa Pines cover the hillsides not disturbed by mining. The Open Cut, a large surface mining pit part of the Homestake Gold Mine, borders the north edge of Main Street in the heart of the Lead Historic District.

Landscape and topography are critical features associated with the development of the district. The city is built on steep hillsides and terraces, and the district reflects the successful integration of the built environment and the rugged terrain. Lead is not laid out in a standard grid plan with straight streets and square blocks. The often-steep, narrow streets follow the curves of the hills and houses are placed closely together along the terraces. Despite their winding configuration, the streets are oriented either east/west or north/south with only a few, minor angled roads.

There is little room for landscaping other than small gardens, though small trees are planted in less-dense neighborhoods. The majority of the houses are very close to the street or alley. Retaining walls are common and prevent subsidence.

Another identifying feature of Lead's landscape are the number of garages and carports that are suspended from one terrace to another. Other garages are built into the sidehill, inset within the

lot. These “inset garages” are a unique element that illustrate adaptability to the challenging landscape.

Approximately eight-five percent of the primary structures in the district are houses. Commercial buildings compose under ten percent of the primary structures. Roughly five to seven percent of the primary structures are classified as “other,” which includes churches, schools, government buildings, and mining-related features. The majority of the mining-related structures are no longer extant; the Barrick Gold Corporation, which purchased the Homestake Mine in 2001, demolished the structures during early 2000s reclamation projects.

Lead was a “company town,” in which the Homestake Mining Company owned most of the land and constructed housing for its workers. Therefore, most of the houses are single-family and have an architectural continuity that trends modest. Most dwellings are best classified by their architectural *type/form*, and represent popular forms such as pyramidal cube, gable and wing, and cross gable. Following vernacular building patterns, some of these dwellings have details or ornamentation that indicate an influence of a particular architectural style, predominately *Late Victorian* and *Late Nineteenth and Twentieth Century Revivals*. Many houses fall under a broad classification of Folk Victorian. Wall cladding ranges from historic wood clapboard, asbestos, and stucco to replacement siding that includes metal, vinyl, and cement board. Single-family homes in the district are frequently accompanied by small garages and sheds.

Multiple-person dwellings are also represented in the district. Boarding houses, apartments, and duplexes are found throughout the district. Garages frequently accompany these structures. Large, styled houses are also present in small numbers. These were the residence of prominent mine employees, bankers, and businessmen and are most often executed in Late Victorian styles. Other structures include commercial buildings, schools, churches, and social halls. The district also includes a large cemetery and the Open Cut.

The district contains 412 contributing resources and 455 noncontributing. Noncontributing garages (167) outnumber contributing garages (70) by over a 2:1 ratio, thus inflating the number of noncontributing resources. The majority of garages in the district are small, single-car units built during the district’s period of significance (1876-1942). Due to their size, many are not used for automobiles but as storage units. As of 2019, many are in a deteriorated to severely-deteriorated condition. As secondary structures, the 167 noncontributing garages are not as significant as the houses, commercial buildings, public buildings, and mining structures that comprise the majority of the district and convey a disproportionate amount of significance. Additionally, high concentrations of noncontributing garages are not found along the boundary in reasonably decreasable areas of the district. Due to these conditions,

Description: This building is a two-story Prairie Four Square house with a hipped roof, four hipped roof dormers and a belvedere at the apex of the roof. The primary façade exhibits a shed roof, full length porch with a poured concrete foundation on the first story and two square bay window extensions on the second story. The clapboard cladding and trim are all wood. Some of the windows, the porch piers, and the trim may be replaced and the belvedere may be a later addition; however, they all are in keeping with the character of the house. A modern, concrete outbuilding addition is present to the northeast of the house.

112 W Addie Street (LA00000551)

Description: This building is a one-story, Folk Victorian side gable saltbox house with an enclosed porch on the primary façade and original clapboard wood siding. No foundation was visible. The porch is wrapped in plastic obscuring the view of most of the building. The doors and trim are all original materials. An attached one bay shed roof garage is present on the northeast side of the building. The garage exhibits all original wood siding, trim, and doors.

Description: This building is a two-story, cross-gable house of no style or possibly a modified Queen Anne, with replacement drop vinyl siding, windows and asphalt roof. The foundation is poured concrete. The original wood work and trim around an enclosed porch are partially intact.

Description: This building is a one story pyramidal roof house with a full basement. The roof and siding are replaced metal and the foundation is concrete block. A hipped roof enclosed entry is present on the east elevation. The doors, windows, and trim are all modern replacement materials. A modern wood deck addition is also present on the east elevation.

Description: This building is a one and a half story gable front house with a full basement. It has no style. There is a hipped roof enclosed porch present on the primary facade. The gable front asphalt roof has cornice returns. Replacement aluminum siding, windows, doors, and trim.

338 W Addie Street (LA00201130)

Description: This building is a one and a half story house of no style with full basement. There is a hipped roof porch on the primary facade. The roof is side gabled with cornice returns and features a front-facing shed dormer. The windows, doors and porch deck all exhibit replacement materials. Foundation clad in vinyl and wood clapboard siding. House is currently condemned and in poor condition.

516 W Addie Street (LA00000230)

Description: This flat roof multi-family, two-story building is no style and appears to be a basement house from street level but is actually built into hill slope. It features stucco siding and replacement vinyl windows. A modern stairway and deck is present on the east elevation which allows access to the street. It is possibly the lower portion of former church with sanctuary removed.

Description: This building is a three story, side gable Craftsman apartment with the lower story below street level. It features stucco wall finishes and clipped gable ends. The ground floor exhibits a shed roof porch on either side of the street level entry which has a shed roof awning. A replacement gable front porch is present over the entry. No foundation visible. Original wood windows with aluminum storms.

Description: This building is a Minimal Traditional home with Neo-Colonial Revival decorative elements. It is one story, side gabled with wood clapboard siding and with a replacement gable front stoop, and a side gable roof. It exhibits original wood windows and

storms with a replacement stoop and door flanked by replacement side lights which are in keeping with original.

Description: This building is a Tudor Revival, or possibly no style, cottage with stucco siding. It is a one and a half story cross gable house with a new bay window on the primary façade and replacement roofing materials. The entry exhibits arched brick work over the door. Decorative brick work is also present on the chimney. A complementary gable front 1 bay garage with stucco siding is present to the north northwest of the house. Original windows with replacement steel storms and replacement doors.

618 W Addie Street (LA00000367)

Description: This building is a one story home with a double pyramidal roof. It is no style and has been remodeled with all modern replacement materials including stone veneer and vinyl siding. No historic materials remain anywhere on the exterior. A modern front gable one bay garage and a modern gambrel roof shed are present to the northeast of the house.

Description: This building is a one story, no style house with a pyramidal roof. It features a gable front entry on the primary façade and a side gable saltbox vestibule on the west elevation. All materials, except for a few windows, have been replaced including the metal siding, asphalt roof, and trim.

Description: This building is a two stories, gable and wing Folk Victorian house with replacement composite siding. It features a hipped roof porch on the primary façade and replacement metal roofing. Some of the doors and windows have been replaced. Description: This building is a two story, pyramidal no style house with all replacement materials.

722 W Addie Street (LA00000342)

C (secondary C)

Description: This building is a one story hipped roof, no style house with a shed roof porch on the primary façade and replacement metal siding. All materials have been replaced except the 3/2 wood windows on the porch but retain the character of the original. A two bay garage with replacement doors is present to the southwest. The replacement doors convey the period of significance. The garage has a flat parapet roof.

Description: This building is a one story, gable end no style house. All materials on the exterior of the house are replacement. A gable front corrugated metal shed is present to the west of the house.

Description: This building is a no style apartment with stucco siding. It has two stories with a shed roof replacement porch on the north elevation. The primary façade is on the second story facing Upper Addie Street to the south. A gable front entry is present on the primary façade. The apartment exhibits a cross gable roof.

Description: This building is a no style house with some Craftsman detailing such as exposed rafter beams and wood entry. It is one story with clapboard siding and a full basement. The primary façade has a hipped roof enclosed porch with original wood windows and a gable front entry with a replacement steel roof. The roof is pyramidal.

Description: This building is a no style house with replacement wood panel siding. It is one story and has an historically open porch that is now enclosed with the addition of new wood paneling and vinyl windows. The building has a pyramidal roof and exhibits new windows and doors. A new one bay plywood carport with a gable front roof and clapboard siding is present to the north of the house.

Description: This building is Folk Victorian with steel siding. It has one story with a half hipped roof enclosed porch on the primary façade. It has a pyramidal roof with a side gable wing with a shed dormer. Some of the windows are replaced. A one bay garage with weather board and steel siding is present to the northwest of the house. The garage is gable front and has a four-section overhead door.

Description: This building is Dutch Colonial with a cross gambrel roof. It is two stories with a hipped roof wrap around porch present on the north and west elevations. A shed roof deck is present on the second story on the north elevation. The building has composite siding with new windows and a new door on the lower primary façade.

Description: This building is no style, with a gable front roof and a shed roof addition on the north elevation that forms a carport on lower level. It is one story with a poured concrete foundation. Statement of Significance Summary Paragraph (Provide a summary paragraph that includes level of significance, applicable criteria, justification for the period of significance, and any applicable criteria considerations.)

The **Lead Historic District** is eligible for the National Register under **Criteria A and C**. It is eligible under Criterion A for **Industry**. It is eligible under Criterion C for **Architecture**. Its significance is statewide. Its period of significance is 1876-1942. The Open Cut is an extension of the first mining activities initiated in 1876, thus initiating the district's period of significance. In 1942, the Homestake Mine shutdown during World War II, bringing construction in the district to a standstill. Postwar construction did not rival that occurring from 1876-1942. There are only approximately forty-five primary buildings within the district built after World War II.

The district is eligible under Criterion A for **Industry** as an outstanding example of a "company town" associated with the Homestake gold mine. The Homestake was one of the largest gold mines in the world and one of South Dakota's largest industries for decades. It owned the land in Lead, planned the city, and constructed most of the buildings. The Homestake mine was the town of Lead and influenced every facet of its development.

The district is eligible under Criterion C for **Architecture**. The district contains examples of vernacular architectural types including cube cottages, foursquare, cross-gable, gable-front and wing, upright-and-wing, gable-end, and side-gable forms. The district also contains examples of Folk Victorian, Queen Anne, Bungalow/Craftsman, Commercial, and Colonial Revival architectural styles. The vernacular forms, which greatly outnumber styled buildings, represent a distinctive type and period of architecture representative to an industrial mining town of the late nineteenth and early twentieth century.

The district meets **Criterion Consideration B** for moved properties. In 1906, a large area around the Open Cut caved in, starting two decades of subsidence in the area. This required the relocation of several buildings farther west along Main Street. Many of these buildings were moved brick by brick. This event is considered significant to the district and occurred within the district's period of significance. Additionally, many of these commercial buildings are architecturally significant to the district. The district also meets **Criterion Consideration A** for religious properties. Churches are found in the historic district but are not the focal point. The district also meets **Criterion Consideration F** for commemorative properties. The Grier Statue is a single marker in the large district.

Beginnings of Lead

Lead, South Dakota, is located in the northern Black Hills in the western portion of the state. The Black Hills arose 1,600,000,000 years ago. Receding seawaters and the subsequent melting of ice sheets during the Pliocene era created large deposits of minerals in western South Dakota.¹ At the same time, underground temperatures and chemical changes beneath the Earth's surface produced gold ore deposits and immense surface protrusions that characterize Lead and the surrounding area.²

Lead is situated in the center of a V-shaped valley along a side stream commonly known as Gold Run. The town includes a central commercial core with residential neighborhoods and mining structures located above on the hills. The steep hillsides require approximately 1,172 feet of wood stairways and roughly 163 feet of iron stairs for access to various parts of town.³

The town was named after the veins of gold ore located in the exposed rock surfaces called, "leads" because the vein typically indicated the direction of the larger, denser deposit.⁴ Gold and other valuable natural resources in the Black Hills were initially protected by the establishment of the Sioux Reservation in 1868. The report of gold from the Custer Expedition of 1874 led to the inundation of the Black Hills in 1875 with white prospectors. The U.S. government was unable and unwilling to stem the flow of gold seekers onto the reservation, so it removed the Black Hills from the Sioux Reservation through the Agreement of 1876. The taking is still controversial today and the Lakota Sioux have yet to accept payment for the Black Hills.

Miners entered the southern Black Hills near the town of Custer, but soon moved north when news of rick strikes near Deadwood Gulch reached them. Prospectors Moses and Frank Manuel, along with Alex Engh and Henry Harney, established the Homestake claim west of Deadwood in 1876.⁵ The claim was later sold to entrepreneurs George Hearst, J.B. Haggan, and Llyod Trevis who formed the Homestake Mining Company.⁶ George Hearst had the capital and resources to transform the claim into a mining operation of tremendous proportions. As early as 1880, Hearst acquired adjoining claims to enlarge the Homestake enterprise and constructed a foundry, blacksmith shop, machine shop, and a company store. With these businesses, Hearst supplied

himself and the surrounding area with all the necessary goods, ranging from groceries and clothing to furniture and buggies.⁷ Hearst and his wife, Phoebe, created the city adding a lumber mill, hospital, library, and numerous other facilities. By the time Hearst died in 1891, he had purchased every surrounding mine adding eleven claims and over 30 acres of land to the company.⁸ The Homestake Mining Company was the driving force in Lead's founding and development, and the history of the mine directly corresponds with Lead's built environment.

Three communities developed in the area currently occupied by the city of Lead. The first, established in 1876 by Robert Jones, was located in the lower section of Gold Run and named Washington (later a northeast subdivision of Lead). Soon after Jones platted Washington, P.A. Gushurst laid out plans for Golden, a small townsite flanking the east side of Washington, which was later called lower Washington. Finally, in July of 1876, a group of men founded a townsite northeast of Poorman Gulch and named the community Lead City. By 1879, Lead City expanded and the city limits incorporated both Washington and Golden into Lead City.⁹

The town plan for Lead initially consisted of Bleeker, Galena, Gold, Mill, Siever, and Wall Streets, which ran north to south, and east-to-west streets Main, Pine, and Saunders. Lots measuring 50 by 100 feet sold at a price of \$1.25 per, and soon the original townsite was re-surveyed and new additions platted.¹⁰ The original town, which contained approximately 138 acres and mineral claims, was mapped by William L. Smith in January 1881. Surveyor George Hopkins mapped the town again in 1885 and illustrated the town lots, streets, and geographical details.¹¹

As the community grew from a miner's camp into a town with a population of over 3,000, Lead residents organized themselves as an incorporated township with a mayor and civic council. The 1891 incorporation also aided the citizens in negotiations concerning surface ownership and underground property rights.¹² Since Homestake owned the mineral rights below existing property and federal law specified that townsites shall not exist on mineral deposits, the city of Lead and the Homestake Mining Company negotiated a contract which issued patents to the mineral claimants within the platted town boundary. The 1892 compromise specified that in return for the right to surface occupation, Homestake would "need to reclaim any surface rights

within ninety days' notice if they were to undermine any particular lot which could potentially cause damage to the surface property."¹³ Lead continued to prosper and added acreage to the townsite. By 1889, city commissioners granted public improvements including the installation of sidewalks, construction of a jail, and improvements to the local fire department. This was accomplished through the levying of taxes.¹⁴

The turn of the century marked a dramatic increase in Lead's population. The 1900 census recorded 6,210 residents and local reports dating to 1905 estimate a population close to 10,000, which made Lead one of the largest cities in South Dakota at the time.¹⁵ Aside from the impact of the Homestake Mining Company, Lead's development at this time corresponded with the Second Dakota Boom, a period of increased immigration into western South Dakota.

In 1892, an unprecedented arrangement between the Homestake Mining Company and the city firmly established the relationship between the two entities. Homestake wanted mineral rights to the land beyond the town itself and applied for patent to the land. Since townsites are prohibited by federal law to exist on mineral land, Homestake hoped to secure all property rights. Residents fought back and kept the case in court until Homestake compromised. In exchange for clear title to the land in and around town, Homestake guaranteed property owners the right to remain on the land.

Lead In the Twentieth Century

In keeping with the increase in population, Lead underwent significant physical changes in the early twentieth century. The Belt Light and Power company supplied a new arc lighting system, the city paved the major thoroughfares, and in 1900 sewer improvements redirected waste through a new drainage system rather than dumping sewage into Gold Run and Whitewood Creeks.¹⁶ In 1902-03, the city passed an ordinance to rename at least two dozen streets and funded brick paving for major blocks along Main Street.¹⁷

The city established a tripartite government headed by two commissioners and a mayor in 1912.¹⁸ The following year Homestake installed a new gas lighting system with street lamps lining Mill and Main Streets and lined all major streets with concrete sidewalks. Lead resembled many turn-of-the-century towns and boasted most of the amenities available through technology.

One of the dominating features in Lead's landscape is the Open Cut, a man-made, roundish canyon created when rock was removed during mining. The Open Cut is the primary source of

gold and where the large vein of ore reaches surface levels. Constant mining enlarged and deepened the cut, and in 1906 a large portion of the surrounding surface caved in, leaving a vast open space and initiating a twenty-year period of subsidence in the area. Homestake's attempts to fill the caved-in portions and to reinforce the mining stopes was ineffective, and several businesses in the downtown area were forced to relocate.¹⁹ Subsidence slippage continued despite the best efforts of Homestake and the city, and by 1921 Homestake closed the mills and shafts located on the Open Cut.

From 1900 to 1920, immigration to America and Lead increased dramatically. Many young immigrant men were employed in the mines. The large number of immigrants who settled in Lead created the rich ethnic heritage that remains today. At least twenty-five different nationalities were represented in the Homestake mine including: Austrians, Bohemians, Bulgarians, Canadians, Dane, English, Finns, French, Germans, Hollanders, Irish, Italians, Mexicans, Norwegians, Poles, Russians, Scots, Serbians, Spanish, Swedes, Swiss, and Welsh.²⁰ While each group impacted Lead's development, the Finnish, Italian, and Slavonian groups were among the largest and had great longevity. World War I and the Immigration Act of 1924, as well as the closing of the Office of the Commissioner of Immigration in 1925, impeded further immigration and by 1930 Lead's population had stabilized.²¹

The increase in population and mining operations resulted in a significant residential growth period between 1900 and 1929. As Lead's population escalated to over eight thousand, nearly doubling the city's residents, the city expanded out from the central core. In keeping with its role as a company town, Homestake built the Homestake Opera House and Recreation Building for residents. It featured a swimming pool, bowling alley, library, and auditorium.²² The Opera House was the pride of not only Lead, but the entire western section of South Dakota. It represented Lead's preeminence in the early twentieth century.

In addition to the many public and commercial buildings downtown, residential neighborhoods multiplied during this period. An interesting fact of the residential growth was the concentration of ethnic "enclaves" or clusters of houses occupied by immigrant groups. These segments of neighborhoods do not contain buildings that are different than other neighborhoods, but they do underlie the self-imposed segregation of early residents.

Lead From the Great Depression to World War II

In stark contrast to the rest of the nation, Lead's economy was relatively strong during the Great Depression because of the mine. The profits from the mining company not only benefitted Lead, but contributed to the economy of the entire area of the Black Hills. Gold prices rose throughout the 1930s and Homestake stock escalated from sixty dollars a share to five hundred dollars per

share. Miners averaged a daily wage of six dollars while the average wage in the rest of the state was one dollar.²³

The population showed no signs of decline, and with the stable economy, Lead witnessed a building boom. Over two hundred new buildings were constructed between 1930 and 1940, a remarkable number compared to the preceding decades and the rest of the nation whose construction slowed during the depression. The *Lead Daily Call* announced in November of 1932 a total of \$140,000 in new permit since March of the same year. More than forty new buildings were completed, and remodeling permits also reached new highs.²⁴ Building permits worth over \$40,000 worth of new construction and remodeling was recorded from January to May of 1933, and by July, forty-six permits for new houses were issued after May first. The shortage of housing prompted Homestake to implement a building program to benefit company employees by building a house for the employees for a ten-percent down payment, followed by low monthly installments at or below rental prices. By mid-1933, approximately half of new houses built or scheduled to be built were part of the program.²⁵ The building boom continued throughout the decade and was not limited to residential dwellings. Newspaper articles in 1936 still proclaimed new construction of houses, offices, commercial buildings, and apartments.²⁶

World War II and After

The war provided challenges for both Lead and the Homestake Mining Company. As part of war production planning, the federal government classified gold mining as a non-essential industry and ordered gold miners to move into copper and iron ore mining. The Homestake Mine was closed down.

New construction, particularly residential, halted during the war as many miners and their families left Lead to find other employment. After the war, Lead's economy and population rebounded, Homestake reinstated their housing program along with a new program for veterans. Homestake resumed its pre-war production standards and Lead regained its economic stability. However, the city did not experience another building boom equal to the one that occurred up until 1941.

The Homestake Mine operated until 2001. It closed due to low gold prices and poorer quality ores that increased production costs. In the early 2000s, the Barrick Gold Corporation began a reclamation project. Many historic mining-related structures were demolished.

ARCHITECTURE

Introduction

Since most of the dwellings in the Lead Historic District are characterized by a basic form or plan with very little exterior ornamentation, and because common architectural forms are repeated throughout the district, a distinction is made between vernacular forms and styled architecture. Vernacular architecture utilizes a simple plan that lends itself to manipulation and accommodates both its inhabitants and setting. Some stylistic features are often incorporated into the design, but vernacular buildings are more indicative of folk-housing. Styled architecture follows established national trends and is applied to middle- and upper-class dwellings as well as public buildings.

Many houses cannot be categorized by style. Instead, these houses are referred to as vernacular, which to the architectural historian means they are functional, domestic forms. Vernacular buildings reflect popular culture and range from very simple to more elaborate designs based on folk-patterns in architecture. One of the primary objectives in studying vernacular architecture is to identify the basic shape and form of the building based on their floor plans rather than exterior ornamentation.

The following sections describe the predominant architectural types represented by buildings within the district. Since many of the dwellings are vernacular rather than stylistic, the defining characteristics are associated with the physical form and plan of the building, as well as fenestration and exterior materials.

ARCHITECTURAL FORMS

Cube Cottage

The cube cottage adapts easily to regional and stylistic interpretations. Usually consisting of three to four rooms, with no center hall, the one-story cube cottage provides inexpensive accommodations that may be easily enlarged through small additions to the original structure. Most one-story cube cottages feature a hipped or pyramidal hipped roof, ranging from low to moderate in pitch. Some variations feature a full or three-quarter-width porch, which may be opened or enclosed, but small; enclosed entry porches are not uncommon. The typical façade fenestration consists of either a symmetrical placement of windows on either side of the center door, or an asymmetrical configuration with an off-center door followed by one or more windows. Windows, if original, are typically one-over-one sash, with narrow framing. Some cube cottages feature leaded-glass transoms or vertical muntins. The primary entrance is almost always located on the façade wall, and a secondary entrance is usually positioned on the rear elevation. The most common cladding materials are weatherboard, stucco, asbestos, and metal or vinyl replacement siding. If exterior ornamentation is present. The decorative elements are commonly associated with Folk Victorian stylistic features such as spindlework, turned balusters, and open porches.

Foursquare

Like the one-story cube cottage, the foursquare is based on a basic floor plan with four rooms and a center hall. The center hall is not always present, but in most cases, the hall provides access to the staircase for the second story. Hipped or pyramidal hipped roofs are most common, and the roofline may feature slightly to moderately projecting eaves with either an open cornice or brackets. The most common cladding materials are weatherboard, stucco, asbestos, and metal or vinyl replacement siding. The façade fenestration is usually symmetrical, with a centered front door flanked by single, paired, or grouped windows that feature either a one-over-one double hung sash configuration or a three- to five-over-one configuration with vertical muntins. Full and three-quarter-width porches with secondary hipped or shed roofs are the most common in the district, and often at least partially enclosed due to the climate. Gabled entry porches, either open or enclosed, are found in some examples. Foursquares in the Lead Historic District generally do not include stylistic ornamentation. They are very simple in their design and reflect utilitarian building patterns.

Cross-Gable

Cross-gable dwellings are composed by either a side or front gable façade intersected by a cross gable. The cross-gable is comparable to the façade gable in size and massing, creating a cruciform plan. Cross-gable dwellings can be difficult to categorize, since they often resemble gable-front and wing plans, but the proportions dictate the classification. Cross-gable dwellings often contain multiple gable ends, that is, each elevation should contain a gable. In some cases, a full, partial, or entry-width porch is located on the façade or secondary elevation with a shed, hipped, or gabled secondary roof.

Gable-Front and Wing

The gable-front and wing architectural type dates to the mid-nineteenth century through the mid-twentieth century. This popular house is composed of a prominent gable end with an intersecting side gable, creating an “L” plan. Open and enclosed porches are commonly located at the juncture of the two gables, in the sheltered “ell” which provided outdoor spaces. Almost exclusively frame construction, the gable front and wing house adapts to varying sizes and massing, although the wing section generally extends at least double the width of the gable front. Shed or lean-to rear or side additions are also common for this house type, and reflect the adaptation of the basic form to accommodate specific needs. Many gable-front and wing dwellings have little or no exterior ornamentation, but Folk Victorian elements such as spindlework, vergeboards, and gable-end infill or Classical Revival features such as rounded porch supports, cornices, and lintels, provide stylistic expression for the otherwise simple house. Other variations include very modest stylistic features not clearly associated with particular styles.

Upright-and-Wing

The upright-and-wing type is similar to the gable-front and wing plan except the gable front is at least one-half story taller than the wing. In most cases, the house features a two-story gable front, or upright, section adjoined to a one or one-half story wing. Inset porches, exterior

cladding and ornamentation, and construction is identical to the gable-front and wing type. In Lead, the upright-and-wing configuration is less prevalent than the gable-front and wing.

Gable-End and Side-Gable

Two of the most common house types in the Lead Historic District include one- and two-story houses characterized by a side gable or gable end façade. In both types, the primary gable (either side or end) dominates the façade. Full and partial porches generally feature a secondary hipped, shed, or gable roof supported by wood posts or enclosed with windows. These houses are popular because they translate well into varying economic, climatic, and geographical conditions, and the basic square or rectangular form is easily manipulated to accommodate large and small dwellings. Below are subcategories of these forms:

Gable-End with Hipped Porch

This subcategory includes frame and stucco gable-end dwellings that feature a full or three-quarter width porch. In most cases, the porch is at least partially enclosed by screens or windows, with an off-center front entrance. The lower façade fenestration generally contains a single door entrance either flanked by single or grouped windows or off-center followed by similar windows. Window configuration is typically one-over-one sash or three- to five-over-one sash with vertical muntins. In most cases, door and window framing is narrow, and the house exhibits little exterior ornamentation aside from slightly extended eaves, sometime with brackets or exposed rafters. This house type is primarily represented by one-story dwellings in Lead.

Gable-End with Gabled Entry Porch or Portico

There are several examples of one- and one-and-a-half story gable-end cottages characterized by a large, primary gable-end façade with a smaller, gabled entry porch (enclosed) or an open, gabled, portico. The general architectural features include slightly projecting eaves with open cornices or bracket eaves, narrow vergeboards, plain lintels, jambs, and sills on window and door openings, a combination of single and grouped (paired or triple) windows with one-over-one or three- to five-over-one lights with vertical muntins. Exterior wall cladding includes weatherboard, stucco, asbestos, and metal or vinyl replacement siding. Roof pitch ranges from low to moderate.

Double Front Gable-End

Another very predominate variation of the gable-end house found in Lead is the double front gable-end type, characterized by a large, primarily gable end and a secondary, slightly projecting gable end. In most dwellings, the one-story secondary gable end is centered on the one-and-one-half story primary gable end and contains either an open or enclosed porch. Many of the double front gable-end houses share common bungalow characteristics such as extended eaves, exposed rafters, bracketed eaves, narrow vergeboards, and low to moderately pitched gables. Siding is stucco, weatherboard, and metal or vinyl replacement.

Clipped-Gable Cottage

The clipped-gable roof provides an interesting variation of the gabled cottage and is characterized by either a cross-gable plan with double front gable ends or single gable-end façade. In both examples, the façade features clipped gables with slightly projecting eaves and narrow rafters. This type is similar in form, utilizing a square or rectangular floor plan with one or one-and-a-half stories, and stucco wall cladding. Like the other cottages, window placement is single or grouped with one-over-one or multiple lights-over-one sash windows and narrow framing.

ARCHITECTURAL STYLES

Many architectural styles are present in the Lead Historic District. However, only five styles – Folk Victorian, Queen Anne, Bungalow/Craftsman, Colonial Revival, Commercial – are present in appreciable numbers. Art Deco, Romanesque, and Classical Revival styles are found within the district, mainly on public buildings and churches, but appear only singularly or in limited numbers.

Folk Victorian

The Folk Victorian style was commonly used throughout the United States from 1870 through 1910. Elaborate porches with turned balusters, spindlework, and railings along with other Victorian Era detailing on simple house forms characterize the style.²⁷ Folk Victorian refers to the vernacular adaptation of traditional Victorian-era stylistic elements. Besides elaborate porches, characteristics include woodwork in gable ends, gable-end infill such as fish-scale shingles or gingerbread, and decorative vergeboards. Folk Victorian forms are typically gable-front and wing, cross-gable, or cube with modest exterior ornamentation (typically to the porch).

Queen Anne

The Queen Anne style was the dominant style of domestic architecture in the western United States from 1880 to 1900. The style came about as a result of the Industrial Revolution, as new technologies began to emerge that allowed builders to use mass-produced, pre-cut architectural trim and other similar decorative elements. It spread rapidly as a result of the wide dissemination of pattern books and an expanding railroad network, which increased the availability of new products. The Queen Anne style persisted with decreasing popularity through the first decade of the twentieth century. Architectural expressions of the Queen Anne style in the district followed national and regional trends, with a dominant front-facing gable, full-length or wrap-around porches, asymmetrical façade, and variations in wall surface to avoid a smooth-walled appearance.

Bungalow/Craftsman

The Craftsman style is well-represented in the district, depicting influence from bungalows and the Arts and Crafts Movement. Due to the promotion of the Craftsman style in pattern books and popular magazines, it became the leading style for smaller houses throughout the United States

between 1905 and 1930. The style originated in California and quickly grew in popularity as it offered a simple and economical alternative to the elaborate Queen Anne designs. The Craftsman style emphasized the use of simple forms and natural materials. A low-pitched roof with wide overhanging eaves, exposed rafter tails and eave brackets, and prominent front porches characterize the Craftsman style. Exterior chimneys and divided light over single pane sash windows also denote the Craftsman style as represented in the district.

Colonial Revival

The Colonial Revival style that emerged in the 1880s was based on the early English and Dutch houses in colonial America along the eastern seaboard. Georgian and Adam styles constituted the backbone of the style, though other secondary influences contributed. Early Revival houses referenced the original architecture of the colonies, but rarely duplicated it, as they tended to differ significantly in size and exaggerated architectural details. Colonial Revival was popular from 1880-1900 and enjoyed another era of strong favor from 1920-1940.²⁸

The Colonial Revival style was fashionable nationwide for houses built during the first half of the twentieth century. It was heavily promoted in print media during the early decades of the twentieth century and became a popular respite from the vibrancy of the Victorian Era as people found comfort in more subtle traditional forms and designs. Features of the Colonial Revival style include a symmetrical façade with accentuated central entry, the use of columns and pilasters, and paired double hung windows, often with multi-pane glazing in the upper sash.²⁹

Commercial

Common in business zones, Commercial buildings are generally identified by multiple stories, masonry or stone construction, multiple bays with large storefront windows, and their incorporation of features from other styles. Commercial buildings can also be further classified by form into One-Part and Two-Part forms. Both of these forms are well represented in the district.

One-Part Commercial Block: One-Part commercial blocks developed in the mid-19th century and were most often used for retail.³⁰ They are only one story tall, usually with large windows on the front façade to display goods. Since these buildings are relatively small, they were often used to stake a claim in urban land since they were cheaper to build than large commercial blocks.³¹ Since the facades of these buildings are dominated by large store-front windows, there is little room left for ornamental detailing.³²

Two-Part Commercial Block: The Two-Part commercial block has historically been the most popular architectural form for small to moderately-sized commercial buildings from the 1850s all the way through the 1950s.³³ They are usually two to three stories high with the different levels serving different functions.³⁴ The first story is often where the store or business space is located and the upper zones function as private space for offices, apartments, hotels, and the like.³⁵ Often these taller commercial buildings have some ornamentation at the roof line or around windows and doors that allows for visual dating.³⁶
